Please refer to your letter No. **OIN2006431** dated **28/05/2025** on the subject.

You are hereby accepted as an approved fabricator of petroleum tank trucks under Petroleum Rules, 2002. The approval is subjected to the following conditions:-

1. The rear end of the tank shall have a metal plate permanently fixed to it showing the manufacturers name and identification mark, Sr. No of the tank, date of manufacturing and capacity.
2. The tank truck shall be fitted with safety fitting(top loading/ bottom loading) approved by Chief Controller of Explosives, Nagpur and such safety fitting shall clearly carry the identification mark, of the Chief Controller of Explosives, Nagpur. approval no. and date Batch no.
3. The tank truck shall be fabricated strictly as per drawing approved by this office and shall be in accordance to Third schedule of Petroleum Rules, 2002.
4. The tank truck shall be taken into use for the transportation of Class 'A' & 'B' petroleum only after obtaining a Licence in Form XI or Form XIX under the Petroleum Rules, 2002 from this Organisation.

**Conditions of the Approval:-**

**If factory license is applicable, it may be obtained within six months from the date of the PESO approval.**

You shall also furnish a performance report on yearly basis, detailing the number of tanks fabricated with Sr. No., details of the customers, Name and address of the suppliers of safety fitting along with quantity purchased.

This approval may be amended or withdrawn at any time if considered necessary in the interest of safety or if any of the conditions as mentioned above are violated or not complied with.

This approval is valid upto **15/06/2026** from the date of issue of this letter.
