1. MSCS Rules 19(I) and as per relevant clauses of Bye-laws of the **Vittalrao Shinde Sahakari Sakhar Karkhana Ltd.**, Members who have been registered in the final voter list will be eligible to vote for the said election.
2. Provisional List of members would be available for inspection at RO / ARO office and **Vittalrao Shinde Sahakari Sakhar Karkhana Ltd.**'s registered office, it's all branch Offices and karkhana website.
3. A copy of Voters list will be supplied to any member/delegate on payment of such fee as may be specified by the Board of Directors of the karkhana.
4. It is mandatory for the candidate, proposer and seconder to be a member of **Vittalrao Shinde Sahakari Sakhar Karkhana Ltd.** And his name must be included in the final voter list.
5. It is mandatory for the candidate or through any person authorized by him/her or his/her nominee, to file a Nomination form in the prescribed format 'Form III' For Board of Directors and 'Form V' for Office Bearer, to the Returning Officer OR Assistant Returning Officer, within the prescribed time limit.
6. The eligibility of the candidate to contest elections as a Board of Director and Office Bearer as per Sec 29, 43 and 44 of the Multi state Cooperative Societies Act and also as per Rules 19J, 19K and 19L of MSCS Rules.
7. And as per the bye-laws of **Vittalrao Shinde Sahakari Sakhar Karkhana Ltd.**, a candidate should be eligible to contest elections as a Board of Director and Office Bearer.
8. Deposit for election shall be Rs.2000 /- and Scheduled Castes and Scheduled Tribes candidates Rs.500/- is Mandatory to attach the receipt of the said deposited amount along with the nomination paper.
9. The candidate filing Nomination form under the category of reserved seats for SC/ST/NT/OBC should attach copy of caste certificate duly attested by self, with his/her nomination form.
10. A candidate or his/her nominee or candidates representative (authorized in writing by the candidate) may give written notice of **withdrawal of his/her candidature** to the Returning Officer or Assistant Returning Officer within the prescribed time.
11. It will be necessary for all the Contesting Candidates to submit the details of their election expenses to the RO/ARO as the provisions of MSCS Rules 19(U), (V), (W), (X) and to adhere to the code of conduct.
