

The Company adopted Indian Accounting Standards ("Ind AS") effective April 1, 2017 and accordingly, the financial results for the quarter ended June 30th, 2017 have been prepared in accordance with the recognition and measurement principles laid down in Ind AS-34 "Interim Financial Reporting" prescribed under section 133 of the Companies Act, 2013. The results for the quarter ended June 30, 2016 are also Ind AS compliant and has not been subject to limited review report or audit. However, the management has exercised necessary due diligence to ensure that the financial results provide a true & fair view.



Review Report to

1. We have reviewed the accompanying statement of un-audited financial results ('the Statements') of **Agarwal Duplex Board Mills Ltd. (the company)** for the quarter ended 30.06.2017 being submitted by the company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligation & Disclosure Requirement), Regulation, 2015 as modified by the Circular No. CIR/CFD/FAC/62, 2016 dated July 5, 2016.

This statement of un-audited financial results for the quarter ended 30.06.2017 together with the notes thereon is the responsibility of the Company's management and has been approved by the Board of Directors in its meeting held on 30th August, 2017.
