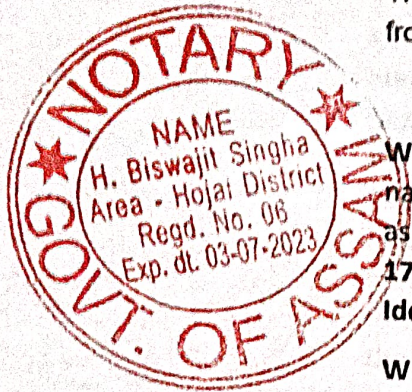


WHEREAS the original LLP agreement has been amended and a capital contribution has been made and a supplementary agreement has been entered on **13th Day of June, 2020.**

WHEREAS the original LLP agreement is being amended for the third time for resigning of a partner and amendment in capital contribution by this supplementary agreement dated **01st Day of February, 2023.**

- Resigning partner will pay the income tax on his/her income & other settlement funds received. As per Income Tax Act 1961, IT Tax payable by LLP will be paid by LLP.

- It is declared that except as hereinafter provided the Resigning Partner shall have and be hereby releases all his share, right, title and interest in the business of the LLP, its assets including goodwill, all licenses and permits held by the LLP, its outstanding dues and receivables and outstanding contracts, that the same shall belong to the Continuing Partners alone.

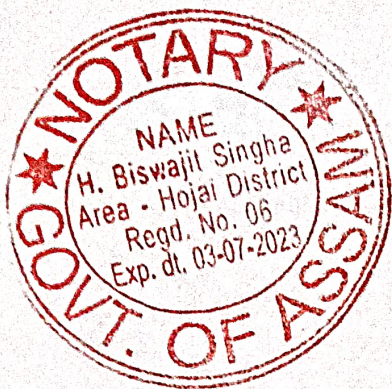
- As agreed between resigning partner and continuing partners, Continuing Partners have been and will be entitled to continue to LLP Business.

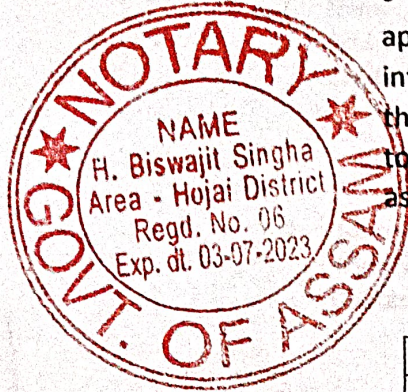

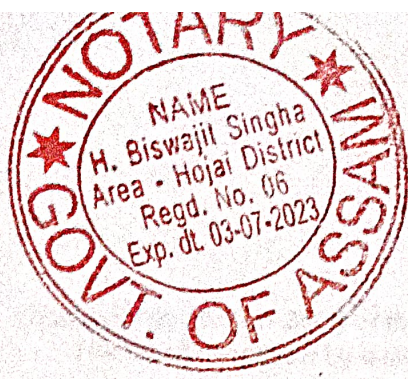

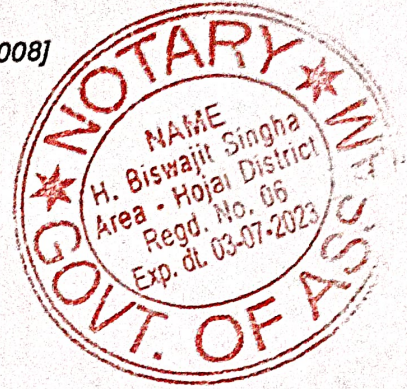
